The purpose of the Pastoral Signature Loan Program is to provide additional cash during a time of need. MINISTRY IN ACTION

Appalachian Trail Chaplaincy - *ministry on the trail, one-on-one, one step at a time.*

Each year since 2013, the Holston Conference of the United Methodist Church has selected a Chaplain to thru-hike the 2,190 miles of the Appalachian Trail between Georgia and Maine. A challenging trip on foot while carrying sleeping bag, supplies, and food in a backpack. The focus of this unique ministry is befriending hikers, providing a listening ear and a helping hand. To show the love of God to individuals who are often on a spiritual journey as well as a physical journey. The thru-hiker Chaplain begins their hike in early spring or summer, culminating in the fall before the weather turns cold.

Matt Hall, 2017 AT Chaplain, a beginner hiker recovering from substance addiction and taking on more than he could imagine, learned "No matter how nervous you feel, when you're hiking, you have no choice but to put one foot in front of the other. Life becomes very simple when it's one step at a time. The trail became its own world. The farther I hiked, the more I felt God was beside me, step by step, guiding my way as he had since I got sober." Matt became Chairman of the Board for Appalachian Trail Chaplaincy after his service as trail Chaplain.

MOBILE BANKING

Become an Expert at Digital Wallet



Interfaith FCU branded debit and credit cards may be added to the Digital Wallet on your device. Interfaith FCU supports IOS, Android, and Samsung devices. This will enable you to make purchases without a physical card. Faster checkout as you hold your phone over the payment terminal and verify the purchase. Look for the Touchless Payment icon seen above indicating digital wallet is accepted.

Making purchases with digital wallet provides additional security to your transactions. Your full card number is not displayed anywhere in your digital wallet. There is advanced encryption of your payment information. A single-use random payment code is utilized for each transaction.
